

2. APPLICATION FOR ORDINARY PASSPORT (BURGUNDY COLORED)

Regardless of the age and the reason for application (lost passport, etc.), in-person application with an appointment on www.konsolosluk.gov.tr is required. Applications via mail in NOT accepted.

Required documents:

1. Turkish ID (*Turkish driver's license or US IDs are NOT accepted*),
2. The current and old passport(s),
3. One (1) biometric photo (*Background: All white. Must be ready before the appointment time.*),
4. Police report for the lost passport,
5. ID of the custody holder, along with its photocopy if the applicant is under 18.

Important Notes:

Those. who are NOT over 18, can only get a passport with a 5-year validity.

Those, who are under 18 (including babies and toddlers), have to apply **in person with** their mother or father or legal guardian, by **getting an appointment**.

If one of the parents or the legal guardian cannot be present at the time of the passport application, the absent parent/guardian must provide a notarized consent letter approved by a U.S. notary public and a county clerk, along with a photocopy of their Turkish identity card (T.C. ID card/nüfus cüzdanı). (A sample consent letter is provided as an attachment to this document.)

If the custody of the child has been granted to one person by a court decision, the legal guardian must be present with the child during the application, and submit the court decision regarding custody.

If neither parent nor the guardian can be present with the child at the time of the application, both parents or the guardian must provide a power of attorney to the person accompanying the child, allowing them to apply for the passport. This power of attorney must be presented at the time of application.

Persons appointed as guardians by U.S. courts cannot apply for a passport for the children without the other parent, if the relevant court decision has not been recognized by Turkish courts, and registered in the Turkish census records. In such cases, the consent of the other parent is absolutely necessary.

How to receive your Passport:

Passports cannot be issued upon application. When your new passport will be mailed to our Consulate General, you will get an e-mail and you have 3 options to receive your passport.

- 1- You can pick up your passport in person with old and current valid Turkish passports.
- 2- You can authorize someone to pick up your passport in person with your application form and current valid Turkish passport (if you have one.) (*)
- 3- You can send us a prepaid return envelope (with a tracking number) along with old and current valid Turkish passports. We will mail your old and new passports to your address.

Additional Important Notes:

In order to receive the new passport, the old passports must be submitted

As your new passport being issued, if you lose your existing passport, you cannot get your new passport. In this case, you must make a brand-new application for lost passport.

Passports are not extended. Thus, once your passport expires, you must apply for a new passport.

According to Law 5682 of Passport, you must have a valid passport all the time. If you have 10-year gap or more between the expiration of old passport and the date of your application for a new one, the fee of 10-year duration and the fee for actual passport will be charged.

Example: *If your passport expired in 2019 and you apply for a new passport with a 10-year validity in 2024, your passport will only be valid until 2029.*

If your passport expired in 1998 and you apply for a new passport with a 2-year validity in 2024, you will be charged for 10-year passport fee and 2-year passport fee.
